

TECHNICAL SERVICE UPDATE

COCCIDIOSIS PROGRAMS FOR AMPROL PRODUCTS

BROILERS

PREVENTION

Amprol 25% or Amprol Plus in the feed at 0.0125% from one day of age until withdrawal, or until another anticoccidial is used. Amprol Plus is used where greater control of *Elmeria maxima* is needed.

TREATMENT

Amprol 20% Soluble Powder or Amprol 9.6% Oral Solution in drinking water at 0.012% for 3 to 5 days.
Severe outbreaks: Use 0.024% for the first 3 days.

COCCI-VAC[®]

Feed Application:
Amprol 20% Soluble Powder or Amprol 9.6% Oral Solution in drinking water at 0.012% at 10 days post-vaccination for one or two days.
Spray Cabinet Application:
Amprol at treatment level if mortality occurs.

LAYERS

Amprol 25% in the feed at 0.0125% continuously.

Amprol 20% Soluble Powder or Amprol 9.6% Oral Solution in drinking water at 0.012% for 3-5 days.
Severe Outbreaks: Use 0.024% for the first 3 days, or use Amprol 25% in the feed at 0.0125% for 2 weeks.

REPLACEMENTS

Amprol 25% or Amprol Plus in the feed at 0.0125% from one day of age until eight to ten weeks of age. Amprol Plus is used where greater control of *Elmeria maxima* is needed.

Amprol 20% Soluble Powder or Amprol 9.6% Oral Solution in drinking water at 0.012% for 3 to 5 days.
Severe outbreaks: use 0.024% for the first 3 days.

Feed Application:
Amprol 20% Soluble Powder or Amprol 9.6% Oral Solution in drinking water at 0.012% at 10 days post-vaccination for one or two days.

TURKEYS

Amprol 25% in the feed at 0.0125% from one day of age until eight to ten weeks of age.

Amprol 20% Soluble Powder or Amprol 9.6% Oral Solution in drinking water at 0.012% for 3 to 5 days.
Severe outbreaks: use 0.024% for the first 3 days.

Feed Application:
Amprol 20% Soluble Powder or Amprol 9.6% Oral Solution in drinking water at 0.012% at 10 days post-vaccination for one or two days.

PHEASANTS

Amprol 25% in the feed at 0.0125% from one day of age until withdrawal at 35 days or older.
